Parent involvement is very important to education, which is why we are inviting you, as parents, to join the Jones County School District **Campus** Parent Portal program, designed to improve communications between school and home. The Jones County School District uses the Campus system to record attendance, grades, and student information, and it has been widely successful. We would like to take a moment to make families who are new to the district aware of this valuable informational resource, as well as reminding existing families what we have available.

By joining this program, you will have timely and secure access to school information about your child(ren) who attend the Jones County School District. Specifically, you will have online access to your child(ren)'s attendance records, testing scores, transcripts, assignments and grades for each class in which your child is enrolled, with assignments updated on a regular basis. You will also see school menus and announcements, which are updated daily. From the Campus Parent Portal, there are also links which will allow you to e-mail your child's teacher(s) with any questions or concerns. Another exciting addition to the Campus Parent Portal is the Mobile Parent App. This free download will allow you to access your student's information from your iPhone, iPad, or Android.

To access the Campus Parent Portal, visit the schools website at jonesco.k12.sd.us. The website also contains school documents, announcements, menus, calendars, and other school information. Please take some time to look over the attached form. If you would like to access the Campus Parent Portal, simply sign and return the Acceptable Use Policy to the school office and we will set up your account. If you already have an account and have forgot your login information, contact the school office and we will reset your account.

Campus Parent Portal Acceptable Use Policy

The Jones County School District is making the **Campus** Parent Portal available as a means to further promote educational excellence and to enhance communication with parents. The **Campus** portal allows parents to view their own child(ren)'s school records anywhere, any time. In return for the privilege of accessing the Jones County School District **Campus** Parent Portal, every parent is expected to act in a responsible, ethical and legal manner. The portal is available to every parent or guardian of a student enrolled in the Jones County School District.

Parents are required to adhere to the following guidelines:

1. Parents will not share their passwords with anyone, including their children, and will not allow computers to remember their passwords.
2. Parents will not attempt to harm or destroy data of their own children, of another user, school or district network, or the Internet.
3. Parents will not use the **Campus** Parent Portal for any illegal activity, including violation of Data Privacy laws. Anyone found to be violating laws will be subject to civil and/or criminal prosecution.
4. Parents will not access data or any account owned by another parent.
5. Parents who identify a security problem with the **Campus** Parent Portal must notify the District technology coordinator immediately, without demonstrating the problem to anyone else.
6. Parents who are identified as a security or harassment risk to **Campus** Parent Portal or any other Jones County School District computers or networks, will be denied access to **Campus** Parent Portal.
7. Parent access to their children's records will be on a continuous bases for all K-12 years as long as their access to the **Campus** Parent Portal for your children.

User Guidelines and System Requirements are attached. Please review them before signing and returning the **Campus** Parent Portal Acceptable User Form. Only by signing and returning the agreement will you receive access to the **Campus** Parent Portal for your children.
